Proof of the existence of a security system if there is a swimming pool

A copy of the *Taxe Foncière* bill

A copy of your ID documents – passport or ID card

A copy of your marriage or PACS (civil partnership) certificate

A signed and dated RIB (your printed bank details) (due to the risk of internet fraud we can only accept bank details communicated in person or via the post)

A priced inventory list if the property is sold furnished
